Apologies for absence

There were no apologies for absence received.

Declarations of Interest

None received.

Matters Raised by Members of the Public

Members of the Gardening Group shared ideas to extend the planting schemes around the village; this included raised beds and tiered planters.

It was agreed that the Clerk will check permissions and licences for the preferred sites with North East Derbyshire District Council and Derbyshire County Council. The Group will then confirm specifications to be approved by the relevant authorities.

The Group also agreed to put a budget together so the Council can consider quarterly amounts to support planting schemes.

Minutes of the Meeting

Cllr Kerry approved of the minutes from the Council meeting and the Finance and General Purposes Committee meeting held on the 24 June 2024, seconded by Cllr Buxton.

Highway Matters/ County Councillor Update

Cllr Jack Woolley was not in attendance from the County Council but submitted the following report:

- > Arkwright roundabout is due to be resurfaced in August 2024.
- Allpits Road has been proposed for a resurface due to some surplus funding available for road repairs.
- > Funding still available for Community Leadership Fund.

It was agreed to report the condition of the road at Church Side and from the development and utilities works on Top Road.

It was agreed to write to the doctor's surgery to ask employees to park with consideration on surrounding streets to allow pushchairs and wheelchairs to pass.

It was agreed to report overgrown vegetation to Derbyshire County Council Public Rights of Way Team on the following footpaths; NE5/3/1, NE5/3/2, NE5/5/1, NE5/6/1, NE5/6/2, NE5/32/1 and NE18/23/1.

District Councillor Update

Cllr Kerry reported that the Council meeting was held this afternoon. It was also reported that the Chair of the District Council has passed away on 13 July 2024, Christine Smith, Vice Chair has been covering duties in the interim.

Clerks Update

The Clerk reported on the following items:

- I. S106 Contributions NEDDC have now received s106 monies from a recent development Land to the East and North of 119 Top Road, Calow (17/01104/FL), and these are available to be spent.
 - Recreation contribution: £8,270.00 to be used for the provision of new play equipment at Eastwood Park Play Area in Calow;
 - Maintenance contribution: £2,350.00 to be used towards the maintenance;
 - To be spent by 05/05/2027.

025/24-25 It was RESOLVED to look at options for new play equipment at Eastwood Park, particularly accessible equipment.

- II. Chesterfield to Willington Stage 1 Consultation will now end on Tuesday 17 September 2024.
- III. Land at Top Road, Calow

026/24-25 It was RESOLVED to sign a further statement of truth to transfer the additional section of land.

Calow Recreation Ground

The Council considered the following items at Calow Recreation Ground.

- I. Community Ownership Fund, the Clerk reported that a number of the organisations awarded funding in round 3 are lobbying MPs to release the funding and provide an extension for delivery of the projects.
- II. It was agreed to look at options for an additional container for the football club so the existing can be repurposed as a store for Council equipment.
- III. The Chair reported that there are still issues with accessing the Charities Commission website to submit the annual return. It was agreed to hold the next meeting of the Recreation Ground Charity on either Monday 16 or Monday 30 September 2024.
- IV. It was agreed that the Clerk will ask for a progress update from the Cricket Club on the footpath, lighting and CCTV installation. It was also requested that vehicles don't drive onto the pitches unless necessary for delivery of materials (and where required avoid the football pitches).
- V. It was agreed to replace existing signage at the orchard with Parish Council signage and details of the produce on the site. The footpath is not being maintained by North East Derbyshire District Council, this will be reported to the authority.
